

**WEST GEORGIA KICKBALL LEAGUE IN PARTNERSHIP WITH THE
DOUGLAS COUNTY, VILLA RICA PARKS & RECREATION & THE
UNIVERSITY OF WEST GEORGIA WAIVER AND RELEASE OF
LIABILITY FORM**

READ BEFORE COMPLETING REGISTRATION

In consideration of being allowed to participate in any way in the West Georgia Kickball League in partnership with the Douglas County, Villa Rica Parks & Recreation & the State University of West Georgia (**referred to in this document as WGKL/DCPR/VRPR/SUWG**) and any related events and activities, the participant acknowledges, appreciates, and agrees that:

- 1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 4) I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS the **WGKL/DCPR/VRPR/SUWG**, their officers, officials, agents, and/or employees, other participants, volunteers, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the pre-game, recreation, play, or post-game events (“RELEASEES”), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law in correction with (A) my participation in the sport of kickball, or (B) my attendance at any social event or gathering that may be organized, authorized, or paid for by the RELEASEES, individual kickball players, or any league or division organized under the RELEASEES or their rules, including but not limited to any functions, and any pre-game or post-game events or gatherings.
- 5) I, hereby consent to the use by the **WGKL/DCPR/VRPR/SUWG** including its agents, assigns and licensees of my name, photo, likeness or film, videotape and/or sound recording of me (collectively, hereinafter referred to as “Information”) to promote or publicize business both internally and externally. I hereby release **WGKL/DCPR/VRPR/SUWG** from any and all liability for using the Information and waive all claims and cause of action against **WGKL/DCPR/VRPR/SUWG** arising from the use of the Information. I also hereby grant perpetual and irrevocable license to **WGKL/DCPR/VRPR/SUWG** to use the Information in any manner, including, but not limited to, reproduction, sale, exhibition, copying, broadcast, and distribution of the Information or any program incorporating the Information it deems appropriate to promote its business and understand that the Information may be edited or combined with other images, sound, text or information. I expressly disclaim all rights to all values and benefits **WGKL/DCPR/VRPR/SUWG** may gain through the use of the Information.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY FOR THE OPPORTUNITY TO PARTICIPATE IN KICKBALL.
